Section 4. First-aid measures

Description of necessary first aid measures

Eve contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10

minutes. Get medical attention. If necessary, call a poison center or physician.

Methods and materials for containment and cleaning up

Small spill


