### Section 6. Accidental release measures

#### Methods and materials for containment and cleaning up

Small spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. # Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures**
