## Section 4. First-aid measures

#### **Description of necessary first aid measures**

#### Methods and materials for containment and cleaning up

Small spill

# Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**

: Put on appropriate personal protective equipment (see Section 8). Avoid exposure obtain special instructions before use. Do not handle until all safety precautions have been read and understood.
