Section 4. First-aid measures

Description of necessary first aid measures

Eye contact

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Environmental precautions

Methods and materials for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures
