### Section 4. First-aid measures

### **Description of necessary first aid measures**

**Eye contact** : Get medical attention immediately. Call a poison center or physician. Immediately

flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes.

Chemical burns must be treated promptly by a physician.

### Section 6. Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

### For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapor or mist. Provide adequate ventilation. #### **Environmental precautions**

### Methods and materials for containment and cleaning up

#### Small spill

### Large spill

#### Precautions for safe handling

#### **Protective measures**
