Description of necessary first aid measures

Precautions for safe handling

Section 8. Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation. 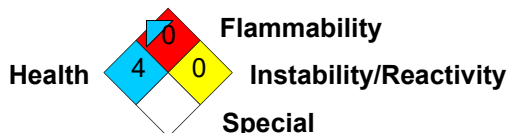
