## Section 4. First aid measures

### Description of necessary first aid measures

### Methods and materials for containment and cleaning up

## Section 7. Handling and storage

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). #### Appropriate engineering controls
