Section 4. First aid measures

Description of necessary first aid measures

Section 7. Handling and storage

Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. - Appropriate engineering controls** : Use only with adequate ventilation.
